



Unfortunately it looks as if we're going to incur higher gas prices due to a provision of the Global Warming Solutions Act of 2006 (also known as AB 32) that goes into effect on January 1, 2015.

Signed into law by former Governor Arnold Schwarzenegger, AB 32 is designed to fight climate change by capping greenhouse gas emissions from all sources throughout the state. Beginning January 1, 2015, the caps will be applied to companies that produce transportation fuels, including gasoline. That means oil companies will have to pay for the greenhouse gases their products emit above the cap limits. The oil companies say they will pass this cost on to consumers.

On a different note, I hope you agree with me that it's time to give your hard-working patrol officers a raise. Our officers have invested a lot of time and energy in Echo Park and Angelino Heights and have established strong ties with community members.

Although we try to keep your fees as low as possible, sometimes an increase is difficult to avoid. As a result of the impending increase in gas prices and patrol officer wages, it is likely we will need to increase monthly dues in 2015.

Fatal Stabbing at Echo Park Rising Festival

The Echo Park Rising festival was marred by violence last month when a man in his 20s was stabbed to death late Friday in a fight that began over a skateboard, police said. Highland Park resident Carlos Arellano. 22. was walking with

his girlfriend on Sunset near Laveta Terrace at about 11:30 p.m. on August 15 when he was approached by three men also in their 20s, said Officer Nuria Vanegas of the Los



Angeles Police Department. The men demanded the board. A struggle ensued. Witnesses said Arellano tried to defend himself with his skateboard before he was fatally stabbed in the torso.

Police have yet to solve the case. Authorities have said the assailants might have been gang members.

Coming Soon: Tickets for Quality-of-life Infractions

Quality-of-life issues such as loud parties, barking dogs, and gas-powered leaf blowers will soon be more than just annoyances. They will be ticketable offenses.

On September 16, the Los Angeles City Council voted to adopt the Administrative Citation Enforcement (ACE) pilot program, which gives police officers the ability to file a misdemeanor complaint as an alternative to just issuing a warning. Citations of \$250, \$500 and \$1,000 for the first, second and third offenses could be issued. An administrative review process would be available for citizens who wish to appeal a citation.

The program was originally proposed five years ago by former City Attorney Carmen Trutanich and former Councilman Greig Smith. Neighborhood councils have long been advocating for the program to help manage quality-of-life issues, which tend to come before them frequently

City officials estimate the program will cost \$577,000 to launch and will generate more than \$2 million in revenue. Officials hope the measure will be ready to go into effect in 60 to 90 days, with a pilot program to be operated by the Department of Animal Services.

Register Your Cell Phone for "Reverse 911" Emergency Notifications at alert.lacounty.gov.

Los Angeles County has implemented an emergency mass notification system to contact County residents and businesses via recorded phone messages, text messages, or email messages. The system, called Alert LA County, will be used by the County's Emergency Operations Center to notify residents and businesses of emergencies or critical situations and to provide information regarding necessary actions, such as evacuations. If the call is picked up by an answering machine, the system will leave a recorded message. If the number called is busy or does not answer, the system will redial the number in an attempt to deliver the message. The system is TTY/TDD compatible.

Listed and unlisted landline numbers are automatically included in the database and do not need to be registered. If you have a cellular or VoIP number and would like to be notified on that device, or if you would like an email notification, you must complete the registration form at alert.lacounty.gov.

Because the Alert LA County system uses geomapping, each telephone number and/or email address can be associated with only one street address in the system.

Northeast LAPD Holds Annual SLO Summit

LAPD's Northeast Division held its annual Senior Lead Officer (SLO) Summit at Barnsdall Park in Hollywood on July 24th.
